SWEARING IN OF NEW BOARD MEMBER

The oath of office was delivered to Brett McGriff by Board Secretary Sarah McGriff.

APPROVE DROPOUT PREVENTION APPLICATION

A motion was made by Vanderwilt and seconded by Morris to approve the dropout prevention application modified supplemental amount of \$72,661. Motion carried.

APPROVE LOAN FROM THE GENERAL FUND TO FUND 69 TO FUND THE WARHAWK CAFE -GRANT FUNDS WILL REIMBURSE

The district's administration is authorized to loan \$7,303.00 from Fund 10 to Fund 69 with the requirement that the funds must be repaid before October 1 of FY24 and interest must be paid from fund 69 to fund 10 at a rate of .6000%. This interest rate is authorized and has been established as the interest rate the funds would have earned in the district's checking account should they not be loaned to Fund 69 for use. A vote was taken to approve the resolution.
